## 2. EBA Lobby and Advocacy

Priority initiatives for Q2 in regard to lobby & advocacy:

- ✓ Monitor and coordinate the last version of the Tax Policy draft at the level of relevant institutions (i.e. Parliament)
- ✓ Ensure continuous representation and participation of EBA in the framework of the Economic Council of the Prime Minister (i.e. at the level of the Council's sector-oriented working groups) and of other B2G platforms (i.e. Customs Service Compliance Committee, Tax Service Compliance Committee, Minister of Economy working groups, Minister of Finance working groups, etc.)
- ✓ Monitor the application of the Law on waste (approved in the second reading) and engage in the consultation process of the draft Regulations implementing the aforementioned law (i.e. draft Regulation on packaging and packaging waste)
- ✓ Enhance the dialogue with the Competition Council on competition related issues affecting the business sector and address concrete problems (i.e. break-up of implicit import/export monopolies)
- ✓ Engage actively in actions that aim at reforming and capacity building of certification bodies (i.e. ANSA)
