EBA participated at the following meetings with Public authorities by presenting legal proposals aimed at improving the business climate:

Ministry of Finance:

- EBA participated at the meeting on discussing legal proposals to the **Tax Policy** for 2021 (25.02.2020)

Economic Council to the Prime-minister:

- EBA participated at the meeting at which was debated **The draft law regulating work through a temporary work agent** (3.03.2020)

- Advisory note on the initiative to improve the Regulation on the **subsidizing of job creation** (25.02.2020)



Following the **Round Table Discussions on the 5 years DCFTA implementation Event**, that took place on February 18th and based on the private sector request, EBA Moldova highly appreciates the prompt feedback of Mr. [Ion Chicu](#), Prime Minister of the Republic of Moldova, Mr. **Ion Perju** Minister of Agriculture, Regional Development and Environment, and Mr. **Ciubuc Nicolae** and [Radu Mudreac](#), Parliament Committee for agriculture and food industry in the amendment of the art. 21 of the Law no 306/2018 on food safety.

Thus, after today's approval of the respective amendment in both Parliament readings **the new provisions removes barriers to trade and allows food imports whose shelf life is less than 30 days** (especially those that are not produced in Moldova like Greek yogurt, mascarpone cheese, etc.)

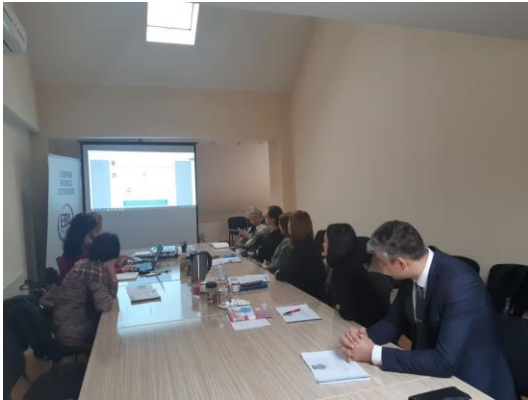
