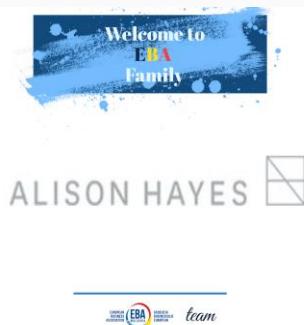
#### **The bilateral business forum Moldova-Hungary (12.03.2020)**
