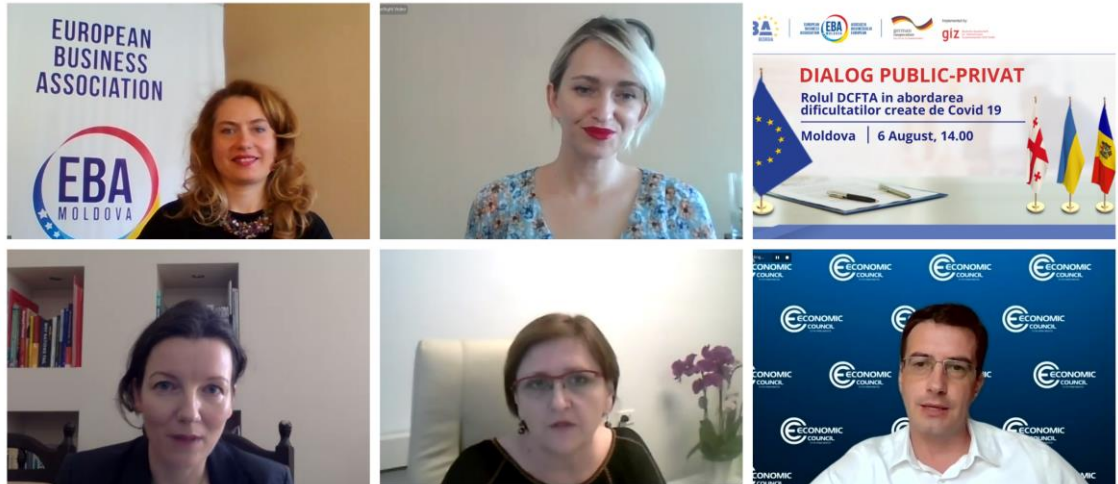

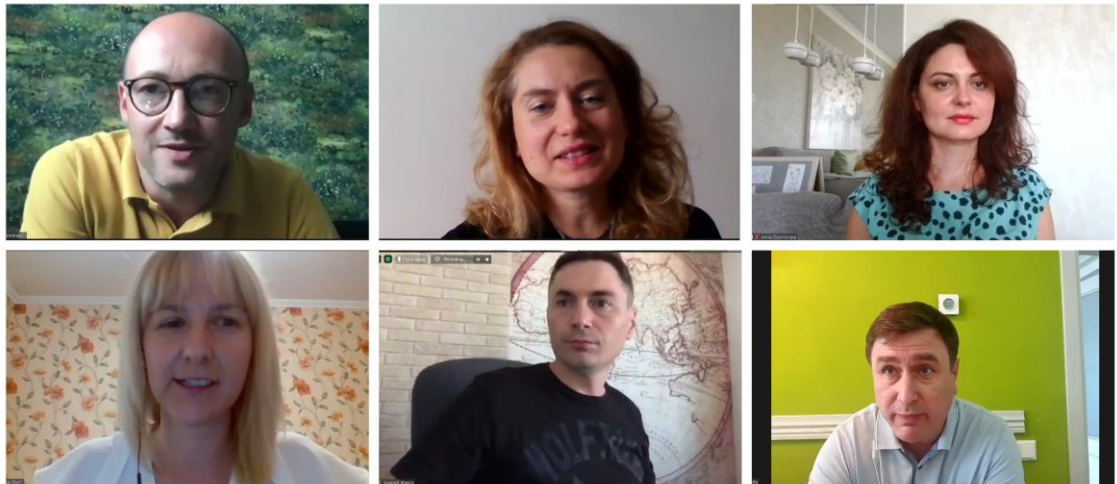

Topic of this workshop: Local taxes during the pandemic and their impact on business.

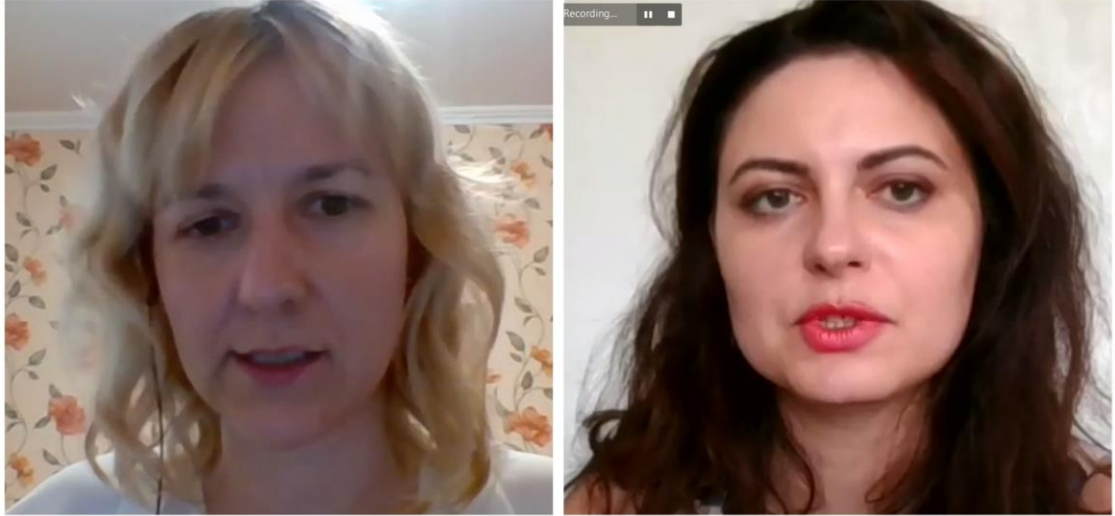

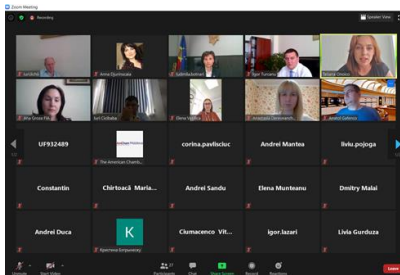

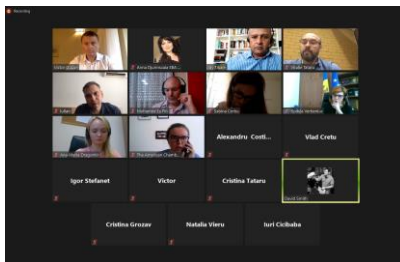
