**Introducere**

2. Cu siguranță a accidentului deosebit, în multe țări ale lumii, inclusiv și în Republica Moldova, de către organele competente de stat au fost inițiate controale privind respectarea de către agenții economici a regulilor de depozitare a munițiilor de armament și regulilor de securitatea industrială, aplicarea de legislația în vigoare.

Luând în considerare că în categoria «industriilor periculoase» se include un număr larg de activități. Va propunem pentru informare prevederile legislației RM, privind securitatea industrială a obiectelor industriale periculoase.
