The event gathered more than 200 participants.

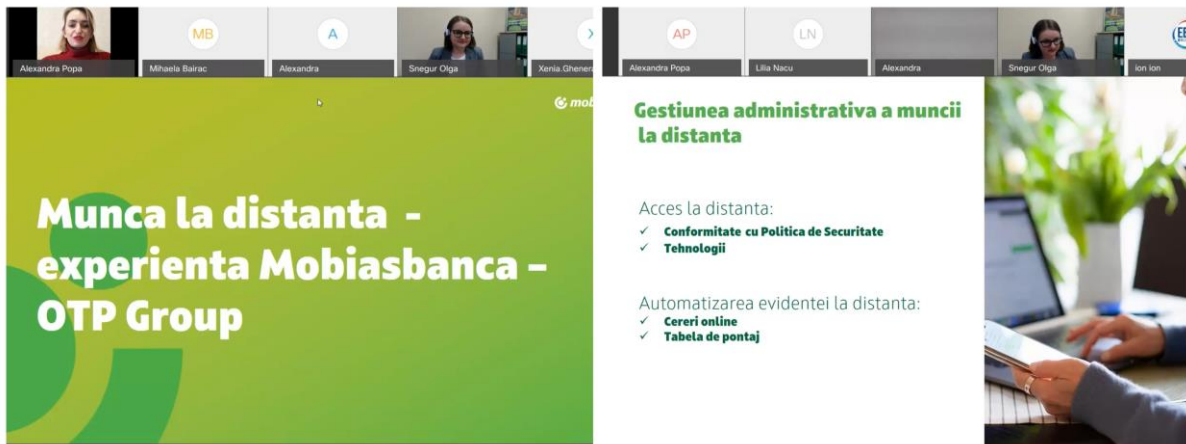
