include the concerns of the regional business community.

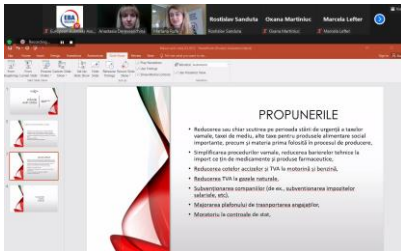

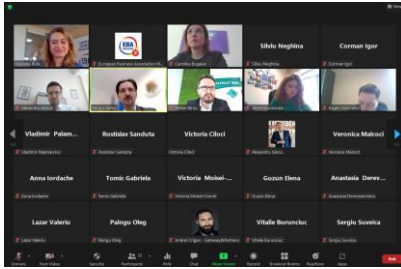
