


I feel privileged to continue our mission as the EBA President in advocating for the best European values and practices to be replicated in the Moldovan business environment.





#### MOLDOVAN EXPORTS TO REGIONS IN 2016-2018, THOUSANDS USD








#### MOLDOVAN EXPORTS TO REGIONS IN 2016-2018, THOUSANDS USD





- The deadline for the subsidy application was extended through amendment of the Job Subsidy Regulation
- The number of the admissions for specialties that prepare professionals for the priority sectors of the Moldovan economy was increased (Government Decisions no 648/2018 and 649/2018)
- Deductibility for the expenses related to the employee (transportation and meal) was increased.

### TRADE IRRITANCIES

# 1. Reducing of barriers for the import of vehicles

#### Amendment of the Annex 2 of the Road Law

#### **Concerns:**

- Facilitate the import of trucks in Moldova and clarify some technical errors in the definition of the autotrains/trucks, provided in the Road Law;
- Reduce the additional financial costs for importers due to expansion of the permitted length of the truck and the need to provide an additional truck to the border so as to unload a part of vehicles from one truck to another (to share) in order not to exceed the length of 18,75.

#### **Recommendations:**

• Amend the Annex 2 of the Road Law, by increasing the truck length from 18,75 m to 20,75m and to amend the definition for the autotrains/trucks used for the import of vehicles, to comply with the 20,75 m length.

#### **EBA Input:**

Following technical meetings within the Ministry of Economy and Infrastructure aimed at discussing
the improving of the legislation related to the import of vehicles, 2 advisory notes were developed &
submitted to the Parliament Committee on Economy, Budget and Finance and Ministry of Economy
and Infrastructure.

#### **Status Quo/Achievements:**

 The Road Law no 509/1995 was amended twice according to EBA's proposals (Law no 190/2018 and Law no 214/2018).



Technical meeting on improving the Legislation/ regulations related to the import of motor vehicles in the Republic of Moldova organized by Ministry of Economy and Infrastructure.

### 2. Technical Barriers to Trade

#### Domestic trade

#### **Concerns:**

- Approve the draft law on amendment of the Domestic Trade Law with those provisions that have been agreed between all interested stakeholders;
- Clarify the regulations on the relationship between suppliers and retailers;
- Establish a relevant trade discounts of the supplier's sales price, making this provision consistent with the basic principles of effective and loyal competition;
- Improve the requirement of the trader to purchase and ensure shelf life of food products from the short food supply chain in the proportion of at least 50% of the linear length of the commercial shelf;
- · Ensure that the EU competition related rules are respected.

#### **Recommendations:**

• Amend the Domestic Trade Law as to protect the rights and interests of businesses and citizens against anti-competitive practices and unfair competition.

#### **EBA Input:**

 Build dialogue with the Parliamentary Committee on Economy, Budget and Finance, Ministry of Economy and Infrastructure, Delegation of the European Union and submitted a position paper by presenting proposals of the business community.

#### **Status Quo/Achievements:**

• Even if, the Parliament Committee expresses openness and support to the business environment, the Domestic Trade law have been withdrawn for 2 times from the agenda of the Parliament Committee and it is still frozen at the Parliament.

## Import of meat (as raw materials for meat processing industry)

#### Concerns:

- Avoid the consumption of the EU quota for import of pork and poultry mostly by traders and to reduce the increase of the price on raw materials on the local market;
- Ensure a sufficient volume of chilled pig and poultry raw materials on the local market;
- Reduce the decrease of the monthly industrial production indices of the meat processors, in the context of the raw materials deficiency;
- Diminish the financial costs of the meat processors who has to pay import taxes which are quite significant, after the finalization of the quotas.

#### **Recommendations:**

• Increase the annual import quota by developing a strict mechanism for the distribution of quotas and to examine the possibility of allocating a special quota for meat processors.

#### **EBA Input:**

 Organized technical meeting with Ministry of Finance, Ministry of Economy and Infrastructure, Ministry of Agriculture, Regional Development and Environment, Economic Council to the Prime Minister, aimed at presenting an analysis on the issues related to import of meat.

#### Status Quo/Achievements:

• The issue is still under discussions with the Ministry of Economy and Infrastructure.

## Export of the processed agricultural products /ethyl alcoho

#### **Concerns:**

- Ensure a proper implementation of the RM-UE Association Agreement, art. 148 on the Anticircumvention mechanism for agricultural products;
- The increase the existing national ethyl alcohol production capacities and to promote exports of domestic products to the European Union;
- Increase the volume of quota for processed agricultural products/ ethyl alcohol.

#### **Recommendations:**

• Include this category of product in the list of products with increasing export volumes in negotiations within the EU-Moldova Association Committee in Trade Configuration.

#### **EBA Input:**

- EBA presented the issue in various discussions with European Commission, Ministry of Economy and Infrastructure, EU Delegation in Moldova and other interested stakeholders;
- EBA submitted a request to the Ministry of Economy and Infrastructure to negotiate the increase of quota for ethyl alcohol with European Commission.

#### **Status Quo/Achievements:**

• The existing national ethanol production capacities are constantly increasing and the trigger volume granted for this product is annually exceeded in a proportion of around 400%. Even though the request to increase the volume of ethyl alcohol was presented at the meeting of the Association Committee in Trade Configuration held in October 2018, the issue still remained unsolved.

#### **Export of walnuts**

#### **Concerns:**

• Export of walnut remains an important issue in Moldova EU exports. The problems encountered by companies are related to the additional verifications carried out by the Customs Service's investigation department with the aim to verify the origin and traceability of the exported product. The issue is also related to unclear procedures applied by the Customs Service in screening the origin of the walnuts, significant quantities of which are acquired from individuals. Besides all the taxes that the walnut exporters pay in accordance with the Tax Code of the RM, they also pay a 5 % withholding tax to ensure the tax obligation of the individuals from whom the walnut was acquired. However, there are clear indications about additional costs incurred related to walnut exports from Moldova to EU, which finally make the Moldovan product uncompetitive on the world market, especially given recent emerging global evolutions on the walnut market.

#### **EBA Input:**

 The respective issues were raised within technical meetings on of the Ministry of Economy and Infrastructure, Economic Council to the Prime Minister, Customs Service and a position paper were presented to the attention of the Ministry of Economy and Infrastructure and Economic Council to the Prime Minister, WTO, EU Commission.

#### **Status Quo/Achievements:**

Despite the multiples EBA Moldova interventions the subject remains unsolved.

#### Illegal taxes charged by ANSA

#### **Concerns:**

- Suspend the charge of the illegal taxes charged by National Agency for Food Safety for the control of imports of the non-animal origin products;
- Ensure the compliance with the provisions of the Association Agreement related to the notification of the European Commission on the legal amendments and national procedures of Moldova;
- Avoid delays of import transactions at the border.

#### **Recommendations:**

- Suspend the collection of taxes for the control of goods at the border until the approval of the Nomenclature of services and their tariffs provided by the Agency;
- Submit a notification to the European Commission on the internal procedures of the Republic of Moldova, in particular concerning the obligation to notify in advance through TRACES system the introduction of non-animal origin products into the country at the border inspection post.



#### **EBA Input:**

 Multiple technical meetings were organized with National Agency for Food Safety, Ministry of Economy and Infrastructure, Ministry of Agriculture, Regional Development and Environment, Center for Reform Implementation, Economic Council to the Prime Minister and proposals of legal amendments were submitted within position documents to the Prime Minister, Controlling Body of the Prime Minister.

#### **Status Quo/Achievements:**

- · The charging of the illegal tax was stopped.
- The official notification to the European Commission was send in December.

## The declaration of maximum retail prices for cigarettes

#### **Concerns:**

- Avoid the reduction of the companies' budget revenues and operational difficulties for wholesalers and retailers due to a big gap of time since the declaration of the price and the sale of cigarettes at a new price;
- Avoid difficulties in adapting rapidly to conditions imposed by external factors such as exchange rate fluctuations, tax changes, costs;
- Reduce the period of declaration of the maximum retail prices for cigarettes.

#### **Recommendations:**

• Amend the Government Decision no 1516/2007, by diminishing the dates of declaration from 20 days to 7 days.

#### **EBA Input:**

• Legal proposals were submitted within a position document to the Ministry of Finance and technical meetings with all relevant stakeholders were organized.

#### **Status Quo/Achievements:**

- The period of declaration was modified according to the recommendations of EBA Moldova (Government Decision no 96/2018)
- Government Decision no.938 was amended and approved on April 3rd 2019.

## 3. Food Safety aspects

#### Food Safety Law

#### **Concerns:**

• Revise the legal framework so as to avoid abuses by the control body related to the withdrawal of the food from the market:

#### **Recommendations:**

• To adjust the draft law according to the practices of the European Union, make it more transparent by clearly defining the documents to be presenting at the customs control.

#### **EBA Input:**

- Organized a technical meeting with the participation of the representatives of the Ministry of Agriculture, Regional Development and Environment and National Agency for Food Safety;
- Submitted an advisory note to the Economic Council to the Prime Minister and Ministry of Agriculture, Regional Development and Environment.

#### **Status Quo/Achievements:**

• The EBA's proposals were taken into consideration and the law was approved (Law no 306/2018).



Technical meeting with MADRM and ANSA on the draft Food Safety Law.

## Border control of the non-animal origin food products

#### **Concerns:**

- Facilitate the procedure of the notification in advance through TRACES system the introduction of non-animal origin products into the country at the border inspection post;
- Diminish the additional financial costs for the importing companies due to new imposed taxes for food safety control;



Technical meeting with MADRM and ANSA on the amendment of the GD no. 938/2018.

- Reduce the technical barriers to trade such as creation of the huge border queues, additional transport costs incurred by the private sector, imposed by the obligation to cross the border just at specific border inspection posts;
- · Design a transparent and clear mechanism of the calculation and application of the tariffs;
- Ensure the compliance with the national legislation by relevant central public authorities regarding the separation of the border control on documentary, identity and physical controls, based on the application of the risk analysis principle;
- Adjust tariffs applied for the control of imported goods, subject of the veterinary, phytosanitary and food safety control based on the current economic situation of the country (including the average salary on economies) and the need to stimulate business and investments in RM, without imposing additional financial burden on the private sector.

#### **Recommendations:**

- Amend the Government Decision no 938/2018 by excluding the obligation to present an additional safety certificate for the imported goods, to offer the possibility for those companies that cannot (for reasonable justification) register in TRACES to submit the notification via email, fax or other means of communication:
- Improve the draft Government Decision on the Nomenclature of services and tariffs for services applied by National Agency for Food Safety by dividing the border control according to risk analysis principal.

#### **EBA Input:**

- Multiple technical meetings were organized within the Economic Council to the Prime Minister, Ministry of Economy and Infrastructure and National Agency for Food Safety with the participation of all interested stakeholders (relevant central public authorities and business associations);
- EBA submitted 3 position documents to the Prime Minister, Controlling Body of the Prime Minister, Economic Council to the Prime Minister, Ministry of Economy and Infrastructure, presenting the proposed legal amendments.

#### **Status Quo/Achievements:**

- EBA presented its proposal for amendment of the Government Decision no. 938/2018. At the end of December, the draft Government Decision was under examination at the Ministry of Economy and Infrastructure, the responsible authority for the amendments promotion;
- Starting with January 16, 2019 the charge of illegal taxes was stopped.

#### **Concerns:**

- Exclude the double certification procedure for the same products imported from EU that have been already certified by the accredited laboratories in the EU:
- Reduce the extensive duration for issuing the certificate of safety, especially for perishable products;
- Ensure the homologation of sanitary-veterinary certificates for animal products imported in RM;
- Grant the possibility to the private sector to transport of samples for laboratory investigations in Romania with the purpose to self-control, especially for those indicators that cannot be made in Moldova.

#### **Recommendations:**

Ammend the Moldovan relevant legislation in the field of food safety.

#### **EBA Input:**

- · Organized a technical meeting for the private sectors representatives with National Agency for Food Safety:
- Position document submitted to the National Agency for Food Safety and Ministry of Agriculture, Regional Development and Environment.

#### **Status Quo/Achievements:**

The issue is still under discussions with the Agency.



Technical meeting at ANSA on elimination of the number of phytosanitary and veterinary certificates.

## 4. Banking sector reform, affecting the access to financing

#### **Concerns:**

• Exclude all restrictions on the transactions with the affiliated persons of the bank, including those presumed as affiliated by the NBM;



Meeting with IMF on addressing related party lending in the financial sector.

- Avoid the blocking of the activity of granting credits, but also of transactions with the persons affiliated to the bank;
- Repeal the lapse of the economic interests of both clients and banks, contrary to economic and business rules:
- Reduce the administrative expenses of the banks that already are too high.

#### **Recommendations:**

 Amend the National Bank of Moldova Regulation no. 240/2013 according to the best practices and EU standards.

#### **EBA Input:**

- EBA Moldova developed a position paper that contains proposals to amend the NBM Regulation, in particular regarding the clear and exhaustive delimitation of the characteristics used by the NBM, so as to limit the risks of concentration of bank exposures to affiliated persons;
- At the request of EBA Moldova, a meeting was held with the representatives of the IMF mission to Moldova, where the banking sector expressed its concerns about the over-regulation of the NBM and its Regulation non-compliance with the EU legislation.

#### **Status Quo/Achievements:**

The NBM Regulation was amended and EBA's proposals were taken into consideration.

#### Anti Money Laundering

#### Concerns:

- Improve the provisions on the applying the national legislation related to the prevention and combating of money laundering and financing terrorism, especially related to the identification of the beneficial owner:
- Simplify the procedures for registering legal entities and opening of the bank accounts;
- Align the National Bank Regulation no 200/2018 with Law no. 308/2017;
- · Reduce technical barriers in starting a business in Moldova.

#### **Recommendations:**

• Improve the relevant legislation related to the prevention and combating of money laundering and financing terrorism.

#### **EBA Input:**

- At the EBA's request a technical meetings where organized in cooperation with Economic Council to the PM on the prevention and combating money laundering and terrorism financing;
- EBA submitted 2 position documents to the Prime Minister and National Bank of Moldova regarding the need to amend the national legislation.

#### **Status Quo/Achievements:**

- Agency for Public Service amended its Regulation that provides the procedure of the identification of beneficial owner (No 05/01 24 from 18 January 2019);
- The National Bank of Moldova presented an official document with explanations on the applicability of NBM Regulation no 200/2018.

## 5. Out-door advertising

#### **Concerns:**

- Diminish deficiencies that can affect the economic activity of the companies in the field of advertising
- Consolidate the role of the local public authorities in issuing the public building construction permits, establishments of the advertising sites:
- Avoid additional financial costs for the private sector related to the placement of advertising on the building where the economic agent operates:
- Establish basic principles for the regulation of the out-door advertising in line with international best practices, with a transition period for the business environment to comply with the new legislative requirements.

#### **Recommendations:**

• Improve the draft law as to create a pertinent legal framework in the field of advertising for all interested stakeholders.

#### **EBA Input:**

- EBA Moldova organized a technical meeting with the private sector to collect relevant proposals to the draft law and presented proposed legal amendments;
- EBA submitted 3 position documents to the Council of Europe Office in Chisinau and Parliament Committee on Economy, Budget and Finance.

#### **Status Quo/Achievements:**

• The EBA's proposals were taken into consideration and the draft law was approved in first reading of the Parliament on 11.10.2018 (registered with no 180).

## HUMAN RESOURCE DEVELOPMENT

## 1. Systemic improvement in the Education Sector

#### Deductibility for companies implementing dual education

#### **Concerns:**

- Additional financial cost of the company in the implementation of dual education;
- Lack of a functional cooperation system between educational institutions/ vocational schools and private sector;
- Need to adjust the secondary legislation related to dual education by introducing the definition of "an apprentice in dual education" and introducing the provision regarding the deduction of expenses incurred by companies.

#### **Recommendations:**

 Amend the legislation in order to create a legal basis for the deductibility regime to be applied for the implementation of the dual system in Moldova

#### **EBA Input:**

- Build dialogue with Ministry of Education, Culture and Research and relevant central public authorities for necessary policy changes;
- Developed 3 position documents and submitted to the Ministry of Education, Culture and Research, Ministry of Economy and Infrastructure, Ministry of Finance, Economic Council to the Prime-Minister, Tax State Inspectorate, National House of Social Insurance;
- Organized a Round table discussion on dual education within Moldova Automotive Days;
- Organized 3 technical meetings with Ministry of Finance, Ministry of Education, Culture and Research, Tax State Inspectorate, National House of Social Insurance, Economic Council to the Prime-Minister:
- Presented proposed legal amendments at 2 technical meetings of the multidisciplinary working group regarding the implementation of dual education under the GIZ VET Project;
- Organized a Business Breakfast with Minister of Education, Culture and Research, Mrs. Monica Babuc.

#### **Status Quo/Achievements:**

- · A separate chapter on the deductibility of the costs incurred by companies in implementing dual education was included in the Government Decision no 693/2018:
- A provision related to the deductibility of the costs incurred by companies in implementing dual education was included in the Tax Code 9 Law no 172/2018).

#### Increase of admissions at technical/engineering specialties

#### Concerns:

- · Lack of relevant and qualitative workforce in areas such as engineering services, IT, textiles, construction, architecture;
- Need to link the state orders to the economic priorities of the country and to increase the number of admissions to all specialties with advanced perspectives for the labor market and the strategic and sustainable development of the economy;
- Striking gap between the expectations of the labor market and labor skills.

#### **Recommendations:**

- Increase number of the specialties that prepare professionals for the priority sectors of the Moldovan economy, namely engineering and technology, textiles, architecture and construction;
- Ensure the increase/in certain case maintenance of the technical/engineering specialties at all education levels:
- Ensure the necessary labor force in medium run for the development of the automotive sector in Moldova.

#### **EBA Input:**

- Organized a meeting within the Economic Council to the Prime-Minister on Tertiary education / State Order for the enrollment of students;
- Organized the Business Breakfast with Minister of Education, Culture and Research, Mrs. Monica Babuc.
- Developed position document and submitted to the Ministry of Education, Culture and Research.

#### **Status Quo/Achievements:**

- Government Decisions no. 648 and 649 from 2018 on State Order for the academic year 2018-2019 approved;
- Number of admissions for the specialties in "Electronic and automatic" increased by 35 places and for the specialties in "Textile" increased by 275 places compared with academic year 2017-2018;
- Number of admissions for the specialties in "Engineering" increased by 20 places and for the specialties in "Manufacturing and processing technologies" increased by 3 places compared with academic year 2017-2018.

#### Restructuring of the financing mechanism

#### **Concerns:**

- Need to optimize the financial mechanism of the funding the tertiary institutions;
- Outgraded equipment within education institutions, lack of modern laboratories, software, which would provide the necessary bases for developing the professional skills and knowledge of a specialist:
- The current funding system of the educational institutions does not allow a budget increase with the aim to acquire the relevant educational infrastructure.

#### **Recommendations:**

• Focus the funds on market oriented needs and education infrastructure by making the tertiary institutions more accountable on the manner of funds utilization.

#### **EBA Input:**

- Organized 2 meetings with State Secretaries of the Ministry of Education, Culture and Research;
- Organized 4 technical meetings with Prime Minister adviser on Education of the Prime Minister, Technical University of Moldova, Economic Council to the Prime-Minister, GIZ representatives;
- Developed a position document and submitted to the Ministry of Education, Culture and Research.

#### **Status Quo/Achievements:**

• The draft Government Decision on the financial mechanism is frozen in the Government.

## 2. Application of the **Job Subsidy Regulation**

#### Amendment of the Regulation on job subsidy

#### Concerns:

- Deficiencies and lack of information related the proper application of the Job Subsidy Regulation;
- Insufficient time to submit the request for subsidizing new job.

#### **EBA Input:**

- Organized a technical meeting within the PM Economic Council on technical issues related to practical implementation of Job Subsidy Regulation.
- EBA collected all questions and concerns of the business environment and reflected in a dedicated Position paper, submitted to the Ministry of Finance and Ministry of Economy and Infrastructure.

#### **Status Quo/Achievements:**

- Ministry of Economy and Infrastructure provided technical explanations to additional questions that appeared in the context of the application of the Regulation;
- The deadline to submit the request to obtain subsidies for creation of new jobs was extended from 31 July to 31 August (Government Decision no 754/2018).

# 3. Proper implementation of the Labor legislation

#### Law on security and health at work

#### **Concerns:**

 Lack of knowledge and understanding in the implementation of the Law on security and health at work, due to obligation of establishment of an internal service on the protection and prevention in the field of security and health at work.

#### **EBA Input:**

• EBA Moldova organized the HR Committee meeting. The aim of the meeting was to inform EBA members on the application of the Law on security and health at work.

#### **Status Quo/Achievements:**

• Representatives of the Ministry of Health and Social Protection provided clear explanation on the applicability of the law which is compliant with international practice.



Technical meeting of EBA HR Committee headed by Eduard Gurin and Diana Neagu, Vernon David.

#### Applicability of the Art 111 of the Labor Code

#### **Concerns:**

- Ambiguous interpretation of the art. 111 of the Labor Code by the central public authorities;
- Lack of applicability of the new legal amendments, especially related to the compensation for the public holidays;
- Risk of additional payments for the companies for attracting of the employees to work on rest days and non-working holidays.

#### **EBA Input:**

- EBA produced an Explanatory Note on the applicability of Art. 111 of the Labor Code, recently amended
- EBA has also send a kind request to the Ministry of Finance to issue an official position to avoid any additional payments in case of the private sector, especially in the context of compensation for the days off (public holidays announced by the Government in 2018).

#### **Status Quo/Achievements:**

 Ministry of Finance issued an official position on the applicability of the Art. 111 of the Labor Code, following the last amendments.

### TAX AND CUSTOMS FRAMEWORK

## 1. Improvement of the customs procedures

#### More transparent customs evaluation process

#### **Concerns:**

- Clearly describe the customs valuation process and the amend the GD no. 974/2016 accordingly;
- Provide a proper application of the risk management system, as to avoid technical errors of the custom inspector which is negatively impacting the quality of the customs control;
- Ensure that all 6 customs evaluation methods prescribed in the GD no. 974/2016 are applied. In most of the cases the customs officers disregard the set of documents prescribed in the first method and recur to the application of the method nr. 6 – increased value;
- Ensure that the customs valuation procedure is not dependent on the revenue gap in the state budget, despite the registered revenue gaps;
- Design a clear and transparent solution for the import of those goods that may disrupt the local industries (i.e. textiles and others).

#### **Recommendations:**

 Improve the Government Decision no 974/2016 as to avoid any uncertainties from the private sector on how to properly declare the value of their goods when importing into Moldova and to increase the transparency of the Custom Service when determining the value of the imported goods.

#### **EBA Input:**

 EBA submitted a position document to the Economic Council to the Prime Minister with related proposals to improve the GD.

#### **Status Quo/Achievements:**

• The Customs Service developed proposals to amend the Government Decision no 974/2016, which is under the examination by the business environment.



Technical meeting on improving customs valuation procedure under the Economic Council to the Prime Minister.

#### Recognition of the Authorized Economic Operator (AEO) status

#### **Concerns:**

- Improve the customs infrastructure and procedures in Moldova and Romania, as to facilitate the border crossings, thus to increase exports to the European single market;
- Finalize all internal legal procedures by Moldovan side as to ensure that the Moldovan Authorized Economic Operator (AEO) status is recognized by EU countries;
- · Create a joint Moldova-Romania customs point to reduce queues at the border and diminish significant costs of the economic agents for delays of the Just on Time Contracts.

#### **Recommendations:**

· Create a pilot Moldovan-Romanian project at the one of the customs point in a form of a joint Moldova-Romania customs point.

#### **EBA Input:**

- · EBA raised the respective concern at the various meetings on the Economic Council to the Prime Minister platform, other ministerial committee and meetings and donors' meetings & EU Commission:
- The issue was presented to DG Taxud for consideration.

#### **Status Quo/Achievements:**

The mutual recognition of AEO is still under consideration at the EU.

## 2. Fiscal Policy

#### HoReCa

#### **Concerns:**

Provide a legal base for company to use a lower tax rate for food and beverages;

#### **Recommendations:**

• Amend the Tax Code of the Republic of Moldova with the aim to offer a 10% value added tax rate for food and beverages (excluding those subjected by excise rate) even if the company offers not only accommodation services and catering, but also other activities.

#### **EBA Input:**

• EBA participated at the technical workshop with Minister of Finance and State Tax Authority and presented position paper to the Fiscal authorities & Tax Policy division of the Ministry of Finance.

#### **Status Quo/Achievements:**

The Tax Code was amended according to the EBA's recommendation (Law no 229/2018).

#### Electronic issue of invoices

#### Concerns:

- Provide special cases of issuing tax invoices;
- Reduce burdens on the private sector in case of taxable services within public acquisitions when companies are obliged to issue electronic tax invoices beginning with 1st July 2019.

#### **Recommendations:**

 Amend the Tax Code of the Republic of Moldova by excluding the obligation to issue electronic tax invoices for deliveries of electricity, heating, natural gas, telecommunication services and utilities.

#### **EBA Input:**

• EBA Moldova presented proposals on the legal amendments to the State Tax authorities.

#### **Status Quo/Achievements:**

• The EBA's proposals were taken into consideration and the Tax Code was amended accordingly (Law no 229/2018).



Technical meeting at Ministry of Finance on amendments to Tax Code.

#### Fixed assets' amortization in fiscal purposes

#### **Concerns:**

Improve the methods of fixed assets book keeping and depreciation in fiscal purposes.

#### **Recommendations:**

- Ease the ways of completing the register regarding the book keeping and depreciation calculation;
- Improve the existing Regulation, adjusting it to the needs of users.

#### **EBA Input:**

• EBA submitted a position document to the Ministry of Finance and Tax State Service with proposals to amend the Government Decision no 289/2007.

#### **Status Quo/Achievements:**

· The regulation is under consideration at the Ministry of Finance.

#### Deductibility of expenses for transport and food

#### **Concerns:**

- Optimize the company's expenses in the context of deductibility related costs;
- Offer a possibility to deduct in fiscal purposes all the expenses related to the employee in fiscal purposes.

#### **Recommendations:**

 Increase the threshold from 25 MDL to 50 MDL for cost deductibility for transportation meals accordingly;

#### **EBA Input:**

• EBA submitted a position document to the Ministry of Finance and Tax State Service with proposals to amend the Government Decision no. 693/2018.

#### **Status Quo/Achievements:**

• The EBA's proposals were taken into consideration and relevant amendments were approved (Government Decision no 693/2018).

#### IPC 18 consolidated reporting

#### **Concerns:**

- Ease the financial reporting;
- Ensure the necessary amendments in other legal acts to enable the application of the IPC 18 consolidated reporting;
- Consolidate IPC 18 reporting that shall save time of the accountants as it consolidates more than 6 reports into one.

Driver for change ANNUAL REVIEW 2018

#### **Recommendations:**

• Improve the IPC 18 consolidated report.

#### **EBA Input:**

• EBA organized a practical workshop on the "Form of IPC 18" related to the withholding income tax reporting, health insurance premiums and calculated state social security contributions.

#### **Status Quo/Achievements:**

- The EBA proposals were considered and applied by the State Tax Service and the National House of Social Insurance:
- The payroll reporting system provided under IPC 18 has been simplified/adjusted.



Practical workshop on the "Form of IPC 18" related to the withholding income tax reporting, health insurance premiums and calculated state social security contributions delivered by State Tax Service, Mrs. Parascovia Cebotarenco and by CNAS. Clara Sorocean and Silvia Isac.

## **ENVIRONMENTAL PROTECTION**

## 1. Waste Management

To design an integrated and well-functioning wastes management and environment protection system in Moldova

#### **Concerns:**

- Direct the pollution taxes revenues for the import of packages towards creating and functioning of integrated wastes collection and processing systems;
- Exclude the legal prohibition for processing instruments like incineration and co-incineration
  of solid and food /animal wastes, and to offer the possibility to producers to ensure timely
  wastes processing in various food and industrial sectors. Wastes management industry is
  underdeveloped in Moldova, accordingly the food processors as well as various industrial
  producers have to queue for a very limited number of wastes processors;
- Increase the role of the Local Public Authorities in the process of wastes collection, processing as well as building necessary areas in the villages/smaller cities for wastes collection, segregation and preservation;
- Design a sustainable financial/fiscal system that would support the development of wastes segregation, collection and processing systems;
- Ensure a consistent implementation of Extended Producer Responsibility (EPR) with attempts of promoting the Wastes Regulation only, without adjusting the other necessary legal changes needed with a complex approach to wastes management and environment protection;
- Consolidate the capacities of the wastes management and environment protection surveillance bodies, especially after the Public sector reform. The capacity of the control institution is very limited and with limited knowledge/competence.



Technical meeting on Waste Management organized by Ministry of Agriculture, Regional Development and Environment

#### **Recommendations:**

- Develop an overall concept for wastes management and environment protection that will consider solid/food/animal wastes segregation, collection, processing/treatment by clear allocation of roles and responsibilities to the LPA, business and citizens;
- Revise the Law 1540 by introducing the concept of integrated well-functioning wastes management principle based on EPR, EU Acquis and best European/international practices;
- Ensure legal harmonization related to wastes processing instruments such as incineration and coincineration for solid and food/animal wastes;
- Design sustainable, transparent and functioning financial/fiscal systems to support wastes management process and system in the country like collection, processing, building/creating specialized isolated areas for solid wastes in the regions and municipalities, factories, food industry, meat processing facilities etc.;
- Design transparent, sustainable and functioning system of subsidies for the investors of wastes processing/wastes collection systems.

#### **EBA Input:**

- EBA raised the issue by presenting all the challenges, consequences and practical implications in various industries as well as necessary recommendations on multiple PPD platforms like the Economic Council to the Prime Minister, Moldovan Parliament Committee on Economy, Budget and Finance, Ministry of Agriculture, Regional Development and Environment, Ministry of Finance, Economic Council to the Prime Minister, Donors Community, EU Commission etc.
- EBA Developed 4 Position Papers, Advisory Notes and Official Letter to the PM by explaining the issue, presenting solutions and international experience.

#### **Status Quo/Achievements:**

• Despite long talks on the need to upgrade the wastes management system in Moldova following the EU and International best practices, there is openness from Government to develop a new integrated Wastes Management Concept with a complex approach for Wastes Management and Environment Protection system in the country. Currently there is reluctance in the Parliament to promote the necessary legal changes related to diversifying the wastes collection/processing instruments. The Ministry had multiple attempts in promoting the Regulation on packaging solely without the necessary modification of the relevant law (1540) and normative acts ensuring other components of wastes management system. The Regulation on packaging was blocked by the Government until necessary legal adjustment will be designed and approved.

#### Export of the metal waste

#### **Concerns:**

- Eliminate the obligation to receive a license for the collection, storage, processing, marketing and export of ferrous and non-ferrous metal waste, used batteries and accumulators;
- Create a legal sustainability in this field as the export of metal waste is possible just through obtaining of a written confirmation from the Ministry of economy and infrastructure;
- · Avoid the different interpretation of the Law by the relevant central public authorities.

#### **Recommendations:**

• Amend the Law 160/2011 on the regulation of the entrepreneurial activity through authorization.

#### **EBA Input:**

- Submitted proposals to amend the Law 160/2011 to the Parliament Committee on Economy, Finance and Budget and Ministry of Economy and Infrastructure;
- Ensured a platform for discussions between all relevant stakeholders through various channels (emails, telephone, other).

#### **Status Quo/Achievements:**

• Even if amendments to the draft law were approved in the second reading of the Parliament, the legal act was withdrawn from the draft law regarding the modification of some legislative acts.

### 2. Energy Efficiency

#### **Energy Efficiency Law**

#### **Concerns:**

- Reduce the Energy efficiency obligation schemes imposed on operators of electricity distribution systems and additional financial costs supported by the operators;
- Avoid the tax burden related to the general obligation for large enterprises to perform the energy audit.

#### **Recommendations:**

Adjust the draft law to the best standards and rigors of the European Union.

#### **EBA Input:**

- Organized a technical meeting with the representatives of the Ministry of Economy and Infrastructure with the aim to discuss the issues identified by the private sector;
- Submitted an advisory note with recommendation on the respective draft law to the Parliamentary Committee on Economy, Budget and Finance and to the Ministry of Economy and Infrastructure.

#### **Status Quo/Achievements:**

The law was approved according to EBA recommendations (Law no 139/2018).



Workshop on the primary and secondary Legislation in the field of Energy Efficency and Renewable Energy delivered by Ministry of Economy and Infrastructure.

### REGULATORY REFORMS

## 1. Data Protection alignment & compliance framework **implementation**

#### National laws on data protection

#### **Concerns:**

- · Create the necessary awareness and provide pertinent explanation on how the GDPR is applied in the EU and what are the companies roles and responsibilities in this regard;
- Reduce the risk for companies to misuse personal data of their customers or fall victim to security breaches, that causes not only financial loss, but also reputational damage;
- Present the recently developed requirements to be applied within Private and public sector (Internal policies, rules etc);
- · Notify about ongoing process of development of necessary legal package on personal data protection system implying amendments to 4 laws;
- Ensure that in the process of legal replication of GDPR any types of administrative constraints and over regulations which create additional costs will be avoided.



Technical meeting on data protection with Mr. Sergiu Bozianu, independent

#### **Recommendations:**

- Align national legislation according to the EU GDPR and EU best practices:
- Postpone the entering into force of the Data Protection Law for at least 1 more year.

#### **EBA Input:**

- Practical Workshop to raise awareness of the business community on the rules and policies to be considered by the companies in the field of personal data protection:
- Technical meetings on the national legislation in the field of data protection (4 draft laws);
- · Advisory notes on the 4 national draft laws related to the data protection addressed to the National Centre for Personal Data Protection and the Economic Council to the Prime Minister.

#### Status Quo/Achievements:

- The draft law on National Centre for Personal Data Protection and the draft law on personal data protection are under examination in the Parliament (registered no 421 and 422 from 22.11.2018);
- The draft media regulation law and draft law on prevention and fight against cybercrime are under improvement at the NCPDP.

#### Identification of the beneficiary owner in relation with Agency for Public Service

#### **Concerns:**

- Reduce the technical barriers in starting a business in Moldova;
- · Ensure that APS will register changes in the statute, amendments related to the headquarter location or the nomination of other manager of the company without the obligation to present the information on the beneficial owner:
- Eliminate the obligation of the company to indicate the manager of the company as a beneficial owner, especially in the case of foreign investment companies, whose associates are transnational companies with shares listed on international stock exchanges;

#### **Recommendations:**

· Amend the relevant secondary legislation (Agency of Public Service Regulation) so that the manager of the company would not be obligated to be considered as the beneficial owner in case when the real beneficial owner cannot be identified:

#### **EBA Input:**

- Advisory note addressed to the Prime Minister and the Economic Council to the Prime Minister;
- Technical meetings within the Economic Council and Agency for Pubic Service and discussions with the relevant authorities and institutions.

#### **Status Quo/Achievements:**

• The internal Provisional Instruction of APS related to the registration of the beneficial owner was amended (Decree of the Agency nr. 05/01-24 i /2019).

#### Social insurance (amendment to the Contravention Code)

#### **Concerns:**

- Eliminate the obligation to present payment documents related to the transfer of state social security contributions;
- Minimize deficiencies in the implementation of art. 296 of the Contravention Code and of the point. 2 of the art. 15 of the Law no. 1593/2002;
- Ensure that the Contravention Code is in compliance with the implementation of the single account service for tax payments.

#### **Recommendations:**

Abolish contradictory provision of the related legislation;

#### **EBA Input:**

· Position Paper addressed to the Ministry of Finance, Ministry of Health, Labor and Social Protection, Economic Council to the Prime Minister, State Tax Service, National House of Social Insurance:

#### **Status Quo/Achievements:**

• The art. 296 of the Contravention Code and the point 2 of the art. 15 of the Law no. 1593/2002 were abolished (Law no.178/2018).

# Donors funded projects implemented by EBA Moldova

## **EBA MOLDOVA SUPPORTING AUTOMOTIVE SECTOR** UNDER GIZ PROJECT

In December 2016, EBA created the automotive committee, presided by Draexlmaier Automotives, Moldova.

To the fullest extent permitted by applicable law, we do not accept and do not assume liability to anyone other than the Association and the Association's Board of director for our audit, for this report, or for our opinion.



# RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the National Accounting Standards, the Methodical Indications regarding the Accounting Particularities for Non-Commercial Organisations and the accounting policies described in the Notes to the financial statements, and for such internal control as management determines is necessary to enable the preparation of the financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Association's ability to continue as going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Association or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Association's financial reporting process.
